

Complying with the USA PATRIOT ACT

To comply with the act, we are required to ask new and existing members for identification prior to opening new accounts, adding individuals to existing accounts, and for some transactions such as wire transfers and ACH.

In order to verify the identity of the member, we will request a non-expired government issued identification evidencing nationality or residence and bearing a photograph or similar safeguard.

We acknowledge that some new members will not have a non-expired government issued photo ID card. In those instances we will accept one of the following:

- Statement from a prior financial institution with present address **and** current utility bill with name and present address **and** a social security card.
- Non-expired government issued photo ID from a relative and proof of relationship (e.g., marriage certificate for spouse, birth certificate for parent/child, etc.) **and** a social security card.
- Expired government issued photo ID **and** current utility bill with name and present address **and** a social security card.
- Employer's ID with photo and number **and** current utility bill with name and present address **and** a social security card.
- Current school photo ID **and** a social security card.
